- 2. Only one waiver is allowed if in an environmental category. Example: Only one allowed: (A) reduced setback; (B) reduced trees; or (C) Reduced open space.

- 3. Front setbacks Code or align with adjoining sites' prevailing setbacks.
  - a. Side setbacks Minimum 5 feet, 0 inches.
  - b. Rear setbacks Code or minimum 15 feet (if city wants trees to grow).
  - c. Open Space Reduction up to 50% of code.
  - d. Required trees Reduction up to 25% of code.
- 4. In order to qualify for the incentives offered in ED 1 or ED 1 Ordinance, projects must be consistent with the following uses:
  - a. Residential units only;
  - b. Mixed-use developments consisting of residential and nonresidential uses with at least 96% of the square footage designated for residential use; or
  - c. transitional housing or supportive housing.

All exterior and interior improvements including floor plan design, relative size finishes/materials, etc. among the affordable units, and any non-residential space that could be ministerially converted to a housing unit, shall be comparable. The affordable units shall have the same access to, and enjoyment of, all community amenities/facilities, light, and air, in the residential project.

5. Prevent developers from declaring "economic hardship" and thus being allowed to avoid basic city requirements like site improvements, infrastructure improvements, fees and standards. 6. Any off-menu requests that are above and beyond the stated ED 1 Ordinance guidelines (see 1 above) must go through a discretionary review including public hearings.

- 7. ED 1 and ED 1 Ordinance projects are not permitted in R-1 or directly adjacent to R-1 zones (including alleys) and adjacent to HPOZ's in their entirety, and districts/buildings/sites designated as a historical resource under a local, state, or federal designation (including alleys).

- 9. ED 1 projects shall not be granted in high fire severity zones.

- 4. In order to qualify for the incentives offered in ED 1 or ED 1 Ordinance, projects must be consistent with the following uses:
  - a. Residential units only;
  - b. Mixed-use developments consisting of residential and nonresidential uses with at least 96% of the square footage designated for residential use; or
  - c. transitional housing or supportive housing.

All exterior and interior improvements including floor plan design, relative size finishes/materials, etc. among the affordable units, and any non-residential space that could be ministerially converted to a housing unit, shall be comparable. The affordable units shall have the same access to, and enjoyment of, all community amenities/facilities, light, and air, in the residential project.

- 5. Prevent developers from declaring "economic hardship" and thus being allowed to avoid basic city requirements like site improvements, infrastructure improvements, fees and standards.
  - 6. Any off-menu requests that are above and beyond the stated ED 1 Ordinance guidelines (see 1 above) must go through a discretionary review including public hearings.
- 7. ED 1 and ED 1 Ordinance projects are not permitted in R-1 or directly adjacent to R-1 zones (including alleys) and adjacent to HPOZ's in their entirety, and districts/buildings/sites designated as a historical resource under a local, state, or federal designation (including alleys).

- 2. The Board of the Studio City Neighborhood Council (SCNC) supports Council File 24-0206: Title, Burnt-Frame RVs / Public Right-of-Way / Remediation Prioritization Protocol. Hundreds of immobile or derelict recreational vehicles (RVs) fill our city streets, often in clusters. Many of these RVs are being used as drug dens and for other criminal behavior. Occupants of immobile RVs openly flout our parking laws without consequence. To help combat this scourge, the City has a contract with a recycler to dispose of RVs in disrepair. 73 RVs have been targeted for recycling under this contract. Many RVs have severe fire damage. In the case of hazardous burnt-fame RVs, the Bureau of Sanitation has to undertake a two-week long remediation process. This motion instructs the Bureau of Sanitation to develop a protocol to prioritize the remediation of burnt frame RVs in the public right of way and to report back to the City Council with recommendations for implementation. An efficient plan would help get these hazardous vehicles off of our streets more quickly. This motion is also to be submitted as a Community Impact Statement (CIS) to Council File 24-0206.
- 3. The Board of the Studio City Neighborhood Council (SCNC) requests that Council President Krekorian and Councilmember Raman propose a City Council motion for the implementation of an autonomous license plate reader (ALPR) system in Studio City. ALPRs work by scanning the plates of passing vehicles and providing that information to law enforcement. Officers would have the ability to determine when a specific vehicle had passed by. This information could help track down missing persons or individuals fleeing a crime in a motor vehicle. In November 2023, the Beverly Hill Police

Department used its APLR system to find a serial killer, who was pulled over on a traffic stop and arrested. There have been numerous recent high-profile burglaries of residences in Studio City by sophisticated burglars. Some of these burglars belong to transnational gangs who come here specifically to steal from Angelenos. Most have alluded justice. An APLR system, located near a freeway onramp like Coldwater Canyon and the 101 freeway, would help the Los Angeles Police Department locate burglars and other criminals who have victimized our community with impunity. Councilmember Lee's motion seeking \$250,000 to implement an APLR system in CD 12 was recently passed by the City Council (see CF 24-007). CD 2 and CD 4 should establish a similar APLR

# Radford Studio Center Audience Shows and Events Policies

To attend an audience, show, event, or public meeting at Radford Studio Center, the following items are required:

- Valid Government issued Driver's license if you are driving a vehicle onto the lot. Valid Government issued Identification card if you are walking onto the lot. A Military ID and Passport ID will suffice.
- An adult must accompany minors (17 years old and younger). Student ID cards are preferred for those who have them.

The following items are prohibited on your person while attending an audience show, event, or public meeting on Radford Studio Center property:

- Knives
- Mace/pepper Spray
- Sharp Objects
- Firearms
- Alcoholic beverages
- Drugs (including marijuana for medicinal purposes)


All guests are subject to security screening and search. Guests will be required to pass through a metal detector or screened using a hand-held metal detector.

- Once the audience member has emptied their pockets and turned over any prohibited items, the audience member will be instructed to proceed through the metal detector or screened using a hand-held metal detector.
- Should the audience member activate the metal detector, the person will be asked to step to the side and will be scanned (entire body length front and backside) by the Security Officer with the hand-held metal detector.
- The audience member will not be allowed into the Studio until the Security Officer is satisfied that the individual has nothing on his/her person that constitutes a danger to others.
- Should the guest refuse to be screened, they are subject to being denied access to Radford Studio Center property.
- NO FIREARMS OF ANY KIND ARE ALLOWED INSIDE THE STUDIO. Security Officers who
  detect that a guest is in possession of a firearm should notify the Security Supervisor and P.O.
  IMMEDIATELY.
- Off-duty Law Enforcement in possession of a firearm will be instructed to either return the weapon to their vehicle or turn it over to Security where it will be kept, UNLOADED, in a SAFE, located in the security manager's office.
- Any props or toys that resemble weapons in any way are to be denied or confiscated. This includes props / accompanying costumes.

Each guest/audience member will be required to submit a form of identification which will be tagged with an item that is confiscated and held with security. Guests and audience members will be instructed to pick up their confiscated items at the first (1<sup>st</sup>) level of the Sater parking structure near the elevators at the completion of the event. No personal pets are allowed at any time on the Studio lot.

If, at any time, an audience member or guest, wanders away from their event or meeting space, into an unauthorized area, that person is subject to immediate dismissal from the lot.
