Motion: The Board of the Studio City Neighborhood Council (SCNC) supports a thorough review of our council's (and other NC's) experience with online voting during the 2016 NC election cycle. Dependable and trusted polling mechanisms are essential to underpin the legitimacy of any elected representative or representative body.

The City Council should also use this opportunity to not only vet the efficacy of online voting, but other aspects of the Department of Neighborhood Empowerment (DONE)'s, and other City agencies, such as the Office of the City Clerk, management of the NC election process, including, but not limited to, effective outreach, information dissemination, seat definitions, poll management, election challenges and grievance panel policies specifically related to elections.
