5. **Speaker: Todd Gilman is the new Neighborhood Prosecutor for the North Hollywood Division.** Mr. Gilman will provide insight on his key role in combating crime within our community, discuss the goals of his office, share recent challenges/successes, answer questions and address the concerns of Studio City stakeholders.

Todd Gilman was previously part of the Ventura County District Attorney's Office. As a Deputy District Attorney in Ventura, Todd prosecuted both felony and misdemeanor cases, and was assigned to the Serious/Violent Felony Unit. Todd is a graduate from UCLA Law School and UC Berkeley. (45 minutes)

6. Presentation, discussion, and possible motion regarding Los Angeles Municipal Code section 85.05 vehicle dwelling.

Motion: The Studio City Neighborhood Council strongly supports the extension of the new [Los Angeles Municipal Code \(LAMC\) 85.02 \(Vehicle Dwelling\)](#). The code, effective since January 7, 2017, currently allows fines to be issued to persons dwelling in vehicles on residential streets and within one block of parks, licensed schools, preschools, and day care facilities between 9p.m and 6 a.m. Without an extension, this code will expire on July 1 and potentially allow sleeping in vehicles anywhere and anytime in Los Angeles.

7. **Discussion regarding Graffiti across Studio City** – Discussion of graffiti and visual blights across Studio City. Public Safety committee members would like to hear complaints and will work with stakeholder and owner to remedy in a timely fashion (15 minutes).
8. The Studio City Neighborhood Council Public Safety Committee continues work on drafting a proposal for submission to the Police Panel Commission and to local leaders to attain additional officers and safety reinforcements for Studio City, and overall East San Fernando Valley communities. As the proposal relates to the police divisions of Van Nuys and North Hollywood, covering all of East Valley, representatives from neighboring Neighborhood Councils are invited and welcome to speak at this time (30 minutes).
