## **Trespass Warning**

**602.1 (b)** An individual who does any of the following will be asked to leave the premises: interferes with an employee in the performance of the employee's city duties; or obstructs or intimidates patrons; or enters non-public areas without authorization.

Individuals refusing to leave after such a request will be subject to arrest and prosecution under California Penal Code.

**602.1 (d)** This section shall not apply to any of the following persons:

(1) Any person engaged in lawful labor union activities or (2) any person on the premises who is engaging in activities protected by the California Constitution or the United States Constitution.

## **Aviso: Prohibido El Paso**

**602.1 (b)** Toda persona que intervenga en alguna de las siguientes actividades, se le pedirá que abandone las instalaciones si: interfiere con algún empleado en el desempeño de sus labores para la ciudad, u obstruya o intimide a los clientes, o entre a áreas prohibidas sin autorización. Quien se rehuse a abandonar el lugar después de dicho aviso, quedara sujeto a ser procesado y arrestado bajo el Código Penal de California.

**602.1 (d)** Este artículo excluye a: (1) personal que participe en actividades sindicales legítimas, o (2) a quienes estén en el sitio desempeñando actividades protegidas por la Constitución de California y de Los Estados Unidos.
